
# Vaping

Nationally there has been an increase in the amount of young people who are vaping. To address this and to ensure that our students have the most up to date information we have delivered assemblies and sessions during PSHCE on the topic to try to dispel the many myths surrounding vaping.

One of the biggest concerns around vaping is that young people often do not know what substance is in the device they are vaping from and this may include illegal substances including THC which can be incredibly dangerous to young people.

### **Dark Nights**

As we approach the "Dark Nights" period specifically Halloween and Bonfire Night we are made aware of increasing concerns from the emergency services around the risky behaviour of some young people.

This may include behaving in an unsafe way or being in possession of fireworks, remember the legal age to purchase or to be handling fireworks is 18. We will be speaking to Ecclesfield students about the importance of attending organised firework events and maintaining appropriate distance from bonfires and firework displays.

Halloween can be a fun event for young people to dress up with their friends and have fun together however, it is also a time that can be quite frightening for some of the older or more vulnerable members of our community. We will be speaking to Ecclesfield students about the importance of being respectful if they are "trick or treating" and not causing upset by knocking on doors where they don't know who lives there or where they aren't certain they will be welcome. We will also be speaking to young people about the dangers that can be associated with visiting unknown houses and the importance of not going into an unknown person's property.





## **Exploitation**


Teenagers may often change their friendship groups, interests, hobbies and where they are hanging out quite regularly. As parents and carers, it can feel like a never-ending task keeping up with who they are hanging around with and what they are doing.

With child criminal and sexual exploitation on the rise it is more important than ever to be speaking to your children, ensuring you know who they are talking to both in person and online and where they are socialising in the community.
